All Athletic Directors were present.

I Winter Sports

A. Basketball

1. Boys

Fairfield / Vacaville Varsity game of January 20<sup>th</sup> will resume on Wednesday, February 8, 2012 at 4:00 p.m. at Vacaville High School. No spectators will be allowed.

3. Senior All-Star game

a. Each of the 6 ML school is interested in going forward with this event between the SCAC and the MEL.

b. Mark Wudel will be the MEL contact / chair for distributing information, collecting athlete names, etc. for the MEL.

4. Power Ratings

a. Week 1 of the Section power ratings came out January 30<sup>th</sup>. The ratings will be updated weekly until the end of the season.
