The meeting was called to order at 8:40 a.m. by Commissioner Joan Mumaugh.

All Athletic Directors were present.

I Winter Sports

A. Basketball

- 1. Power Rating Section
 - a. The League power rating is determined by a Section committee. The committee considers strength of opponents, W/L against common opponents, previous Section success and strength of League against like Leagues.
 - b. Mark Wudel explained that with the Power Rating assigned to the MEL, it will be very difficult for some of our schools to make play-offs even with a winning record.
- 2. Armijo / Fairfield Incident
 - a. Will C Wood experienced an similar incident this year where a Fairfield player tried to enter their huddle. The Fairfield player was sent back by the Wood coach before any problems occurred.
 - b. Mark Wudel recently spoke with the basketball officials regarding a player entering the opponent's huddle. The official said the incident was being sent to the National Association for clarification and suggested penalty.
 - c. Joan handed out the "Victory With Honor" 16 principles and recommended that the ADs review these principles with new and veteran coaches on a yearly basis.
