Commissioner Joan Mumaugh called the meeting to order at 8:30 a.m..

I Winter Sports

A/B. Boys and Girls Basketball

1. The All League meeting was held February 20th.
2. There were 4 Section qualifying teams
 - a. Armijo girls
 - b. Fairfield boys
 - c. Napa girls
 - d. Vacaville girls
3. Schedule 2013 Changes
 - a. The start date for Section play-offs have been moved to accommodate play-in games. The date change will affect our current proposed 2013 schedule. The MEL will start Friday, January 11th but will not include a bye between the halves.
 - b. There was a discussion as to whether the second round of League rival games should be moved in the schedule. After discussing the options, the ADs recommended moving the second rival game to Thursday and Friday, February 7th and 8th. The last game of the season on February 12 will be a non-rival League school.
 - c. Mark Wudel will send the proposed new schedule for everyone's review.
 - d. The basketball schedules will be a voting item at the April 18th Board of Managers meeting.
