I Spring Sports

A. Badminton – No Report

D. Girls Soccer

G. Boys Tennis

1. Dave handed out a bill for each school's share of the tennis officials for the League Tournament.

H. Track

II Fall Sports

A. Volleyball

B. Water Polo
