All Athletic Directors were in attendance. The two new Athletic Directors are John Lammon (Armijo) and John Barsotti (Fairfield).

I Fall Sports

A. Football

- 1. Player Status
 - a. Joan reviewed MEL by-law 0.8-6.1 regarding moving players between frosh football and J.V. football.
