A. Pre-season meetings

III Fall Sports

A. Bylaw Changes

1. Football

A number of bylaws were updated to reflect new Section bylaws. Additional changes were made to reflect the changes that have taken place within the league.

2. Water Polo

The changes for water polo are: 15.2- changing the double round robin to triple round robin,

15.3-3- adding clarification to the goal lines, 15.5-3 allows each school to nominate 4 players for all league, and Coaches may only vote for opponents. Lastly, 15.6 --League champion will be determined using all league contests.

A. Fall& Winter

1. Cross Country schedule moved first meet to bottom and move everyone up one. Also there are two meets at Rockville Hills, two at rush Ranch and two at Lagoon Valley.
