## VI Other

### A. AD Reports

#### 1. Soccer

- a. Fairfield did not show for a scheduled match due to transportation problems. Vintage was not notified that Fairfield was not coming so the officials were not cancelled.
- b. May 9<sup>th</sup> will be the All League meeting.

#### 2. Track

For Armijo home meets, the discus event must take place at 2:00 because the infield area will be used. Running events and other field events will begin at 3:30.

### B. Winter Soccer

The CCC requested the MEL review the possibility of moving both boys and girls soccer to the winter. The MEL is not in favor of winter soccer for the following reasons:

1. Grass field – without synthetic turf, rain will result in muddy fields and less than desirable playing conditions.
2. Practice facilities are limited making it difficult to schedule both boys and girls soccer practices.
3. Winter season typically has more cold temperatures and rain than either fall or spring soccer.
4. Administrative coverage would be difficult since basketball already requires administrative coverage.

### C. Softball Triple Round Robin

1. The Athletic Council is recommending softball return to a triple round robin. Some of the points of discussion were:
  - a. More time is spent in tournaments and non-league competition than League competition. League competition is played in the last 5 weeks of the season.
  - b. Tournaments are resulting in students missing multiple entire days from classes.
  - c. League transportation and officials cost money that may be comparable to tournament fees.
  - d. Baseball (considered “like” sport by the Section) plays a triple round robin.
  - e. Badminton traveling with softball wants a triple round robin.
2. This item will be a voting item at the September 7, 2011 Board of Managers meeting.
